Another three months have passed and COVID-19 still has us in its strangle-hold; no Post meetings and no County meetings for the months of January, February, and March, and none scheduled for the immediate future.

On January 4, 2021, Joe and Rick Ambrosino and I worked on the snow blower which had been sitting in the shed since Mike Kersch had donated to our Post before he moved to Florida. Although Mike had it serviced just before he donated it to us, it had been sitting unused for almost two years, and the gasoline in the tank was stale. With a couple of sprays of ether we finally got it started. Rick needed and used it to

clean the walk ways after the several recent snow storms, but it still needs some adjusting as it continues to stall. We plan on looking to find and solve this problem as soon as it gets warmer. Maybe even having it serviced if we can't solve this problem ourselves.

Unbeknownst to us, until we read it in the February 25, 2021, issue of the Merrick Herald, our oldest member, Andrew J. Conlin died on 2/7/2021. I had the pleasure of meeting him a few days before his 100th birthday which was on 8/12/2019, when I went to his home to invite him to Merrick Post's Veterans Barbecue. Unfortunately for us, his family had planned his 100th birthday celebration for that same afternoon. During that visit he told me about his service in the Army during World War II, and also about his 35 years as a NYC police officer. He also told me that he was still driving, "but I'm not driving to Chicago, just locally." Undisclosed sources told me that he was still driving at 101.

U.S. Navy Reserve Captain Robert Hughes, Jewish War Veterans Post members Gary Glick, Mel Cohen, and Steve Steinbaum joined forces with Merrick Post members, Ken Braun, Jim O'Neill, Al Garbarino, Eugene St. John, Rick Ambrosino and I at Montefiore Cemetery on the cold Sunday afternoon of February 21, 2021, for a graveside service for Army Veteran Richard Schultz. Richard was a Purple Heart Vietnam Veteran, a member of Granito-Smith Post 1296, American Legion, my son's father-in-law, and also great friend to my wife and me. Rich became a member of Granito-Smith Post 1296, which is in New Brighton, Staten Island through his co-workers at the New York Daily News. Although members from the Granito-Smith Post 1296 were unable to attend the funeral, they sent a bronze A.L. grave marker and a thank you note, which appears elsewhere in this issue.

Our second oldest member, Colonel Charles P. Kerns, died on 3/1/2021, just three months short of his 101st birthday. During World War II, he served at the Port of Le Harvre, France as an Army Cargo Operations Officer. He was a graduate of both the U.S. Army Command and Staff College and the US Army Transportation School. He also completed the National Security Management Course conducted by the Industrial College of the Armed Forces. In 1974 he was the recipient of the U.S. Army Commendation Medal. As a reservist, he was on the West Point Selection Committee. After 36 years of service and attendance at the Army War College, he retired as a full Colonel on 5/29/1980. Locally he served as Chief and also Fire Commissioner of the North Merrick Fire District. On St. Patrick's Day 2021, Merrick Post members John Murphy, Eugene Lowenberg, Harry Gribbin, Joseph Ambrosino, Al Garbarino, Eugene St. John, Jim O'Neill, Rick Ambrosino and I provided an American Legion Funeral Service for his family and friends.


